1. Introduction

- 1.1. On 24 March 2023, a special resolution was passed to place the Company into Guernsey Members' Voluntary Liquidation. Andrea Harris and Benjamin Rhodes of Grant Thornton Limited, St James Place, St James Street, St Peter Port, Guernsey, GY1 2NZ were appointed as the Joint Liquidators for the purpose of such winding up ("the Liquidators").
